

Contract Dealers' Development Program

In this contract following are referred as:

Dealer Development Program	referred as "DDP"
Member Dealer Development Program	referred as "Member"
Member's Control Panel	referred as Buyer's Panel

I fully agree to the terms and conditions set by TLRM Auction for Dealers' Development Program.

Vehicle Stock:

- 1) TLRM Auction will offer only available stock to DDP. TLRM Auction will not entertain any special demand from the Member to make the specific vehicle available on TLRM Auction.
- 2) TLRM Auction will offer only FOB prices in Yen as its major price with converted amount in Dollar.
- 3) TLRM Auction will provide open option to Member to set its own price while selecting the stock onto the Member's site in any currency. Therefore, Member has to calculate the conversion from Yen or Dollar to local currency.
- 4) TLRM Auction will feed images and data to Member's site same as on TLRM Auction.
- 5) Vehicle will be disappeared from Member's site if sold by any other Member or TLRM Auction's main team. Therefore TLRM Auction will keep the car on all Buyer's Panels, who selected the vehicle, for one day only for information.
- 6) TLRM Auction will allow Member to select unlimited vehicles from available stock. It up to Member's to select or non-select car in Negotiating status.

About Stock Time-line

- 1) TLRM Auction will offer three types of status. a) Selection b) Negotiation c) Sold
- 2) Vehicles status will be shown in Buyer's Panel.
- 3) TLRM Auction will sell vehicle with negotiating status to the Member who will pay first. TLRM Auction will decide to convert the status to Sold on the basis document sent by the Member (buyer) depicting the proof of money transfer.
- 4) Member is free to select and non-select vehicles for its site

About Website

- 1) TLRM Auction will offer free two-page website to the Member with free Buyer's Panel for controlling the stock selection; non-selection; negotiation and non-negotiation status.
- 2) DDP will offer only set format for Member's website.
- 3) DDP will provide limited changes only to Member's site which includes contact information; about us; page information; front-page about us contents and limited color theme. These changes can be made by Member through Buyer's Panel.
- 4) Member is responsible for all contents and modification thereof over the Member's website.
- 5) DDP will offer two types of formats. a) Set Format b) Customized
- 6) Set Format: This is limited format which free for Member.
- 7) Customize: Member is allowed to change the format or design which will be charge \$100 per page as basic HTML page. Flash and heavy graphics will be charges as per requirement.
- 8) Member will allow TLRM Auction to use it own keywords over the Member's website, Meta tags and Website title.
- 9) Member will allow one banner space to TLRM Auction to promote Eyetii Inc Japan or its products.
- 10) TLRM will reserve the right to own Member's domain till the period of use of service. Thereafter, TLRM Auction will charge as per calculations set by market, business value or volume of business between TLRM Auction and Member
- 11) TLRM Auction will reserve the right to own all the contents, photos and data over the Member's website.

About Payment

- 3) In case of security deposit, the confirmation of sale must be sent in place of TT. TLRM Auction will consider is as initial payment made.
- 4) TLRM Auction will bear the charges of website development, domain acquisition, website maintenance and data backup.
- 5) Member must accept the general payment terms of TLRM Auction

About Shipment

- 1) Member must provide consignee and notifying party information well on time
- 2) Cancellation of shipment will be handled as per TLRM Auction terms and conditions for shipment
- 3) General shipment terms will same as TLRM Auction terms and conditions for shipment
